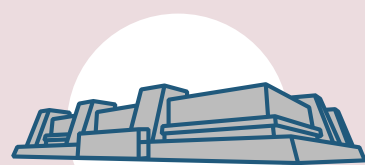

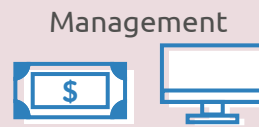

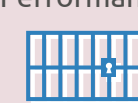

It is a method used to collect data on each of the elements that make up the population from which information is sought.<sup>3</sup>

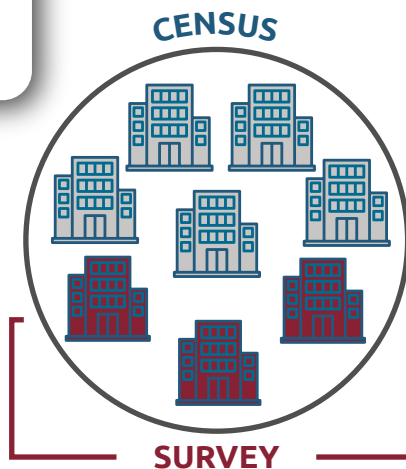
## CENSUS

Collects data from the total set of items of the population from whom information is sought.

## SURVEY<sup>4</sup>

Collects data from a representative sample of the population from whom information is sought.

**Who requests the information?**  
Public servants from the INEGI



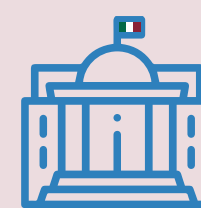
**To whom is it requested?**  
To public servants of the Attorney General's Office of the Republic, for the functions that are entrusted to them, are designated to collect, integrate and deliver the required information, who are better known as informants



**How is it requested?**  
By filling out a questionnaire, which is answered by informants guided by the INEGI public servants

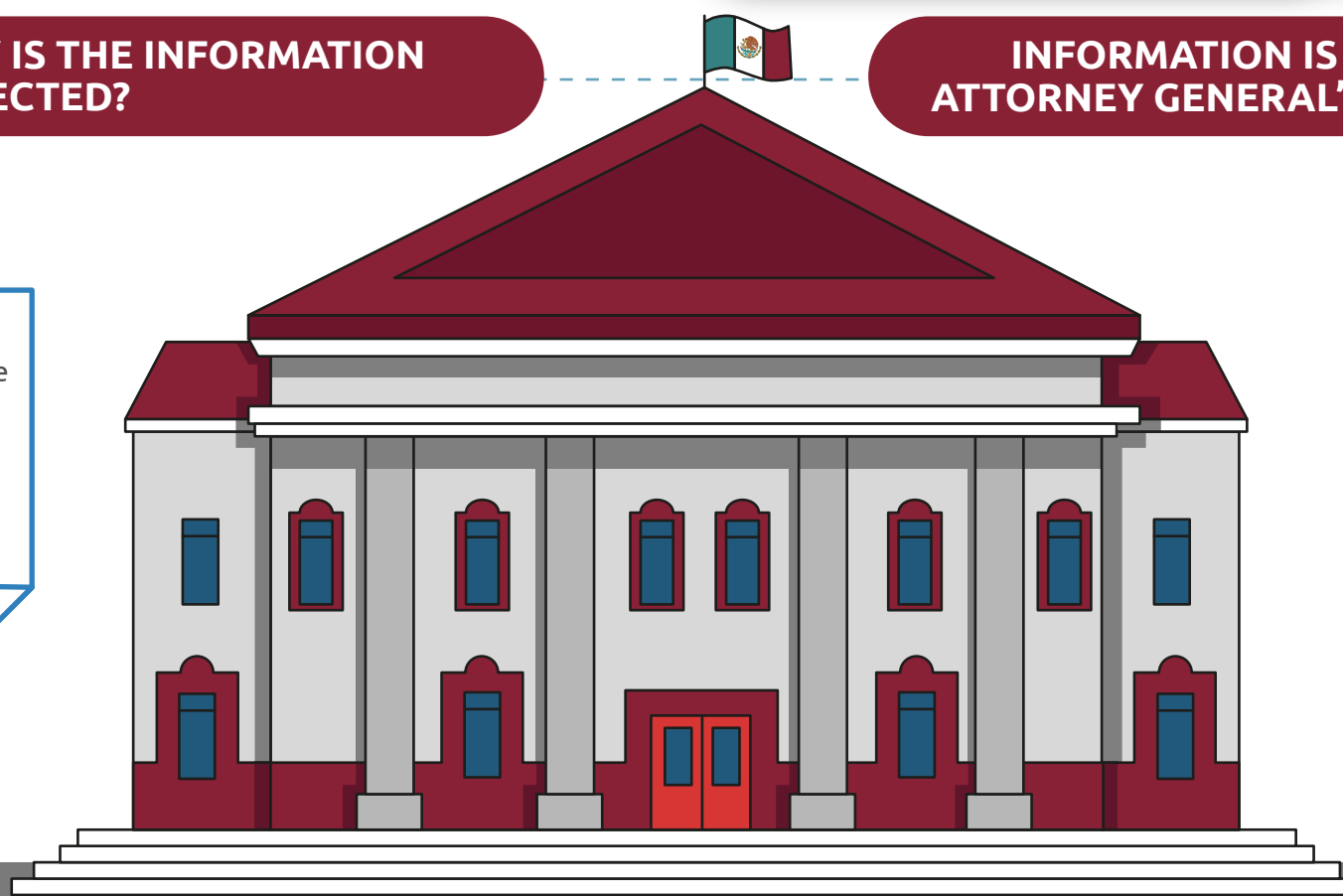
