

## COMPREHENSIVE PRIVACY NOTICE

### SEMINAR: “STATISTICAL INFORMATION OF THE MEXICAN POPULATION ABROAD”

The National Institute of Statistics and Geography (INEGI), with address at Avenida Héroe de Nacozari Sur 2301, Fraccionamiento Jardines del Parque, 20276, Aguascalientes, Aguascalientes, Aguascalientes, between Calle INEGI, Avenida del Lago and Avenida Paseo de las Garzas, makes your knowledge that it is responsible for the processing of personal data obtained in compliance with and exercise of the powers conferred by the Political Constitution of the United Mexican States<sup>1</sup> and the Law of the National System of Statistical and Geographical Information<sup>2</sup>, in this case **with respect to the Seminar “Statistical Information of the Mexican Population Abroad”**, which will be protected in accordance with the provisions of the General Law on Protection of Personal Data Held by Obligated Subjects (General Law on Protection )<sup>3</sup>, and other applicable regulations on the matter.

The INEGI, depending on the information needs required for the exercise of its powers, may collect personal data from the owner, such as: **Full name, sex, age, level of education, institution or company, sector to which it belongs , among others that it requires for the exercise of its powers, without the delivery of sensitive data being necessary;** which will be used to the Seminar “Statistical Information of the Mexican Population Abroad” and the processing is part of the data collection of persons registered as specialized users in order to invite them to conferences and/or seminars organized in the field of research.

In this sense, we inform you that your personal data provided will be treated and protected under the strictest security measures that guarantee its confidentiality, based on the principles of legality, purpose, loyalty, consent, quality, proportionality, information and responsibility, enshrined in the General Protection Law.

The treatment of personal data is carried out based on articles 6, Base A, section II and 16 second paragraph of the Political Constitution of the United Mexican States<sup>1</sup>; 1, 3 fractions II and XXXIII; 4, 16, 17, 18 first paragraph and 19 to 42 of the General Protection Law<sup>3</sup>; 63 and 64 of the Guidelines for Transparency, Access to Public Information and Protection of Personal Data of the National Institute of Statistics and Geography<sup>4</sup>; as well as 32 section X of Internal Regulations of the National Institute of Statistics and Geography<sup>5</sup>.

Likewise, you are informed that personal data will not be transferred, except in the cases of exception established in articles 22, 66 and 70 of the General Protection Law<sup>3</sup> and other applicable legal and regulatory provisions.

From the moment in which the personal data that motivated its treatment is collected, these will be kept for a period of three years, in accordance with the provisions that are applicable and once the period expires they must be eliminated and / or destroyed in any way support in which they are.

Its treatment must comply with the applicable provisions in the matter in question and consider the administrative, accounting, fiscal, legal and historical aspects of personal data.
